This letter is in response to your email and certification form dated July 16, 2013, in which you indicated that Harsco Minerals acquired LVH Industries. The certification form requested transfer of qualification previously granted to LVH Industries to Harsco Minerals under MIL-A-22262B w/ AMD 2, "Abrasive Blasting Media Ship Hull Blast Cleaning."
